NEW BUSINESS

PRESENTATION OF ANNUAL AUDIT

Pam Hill and Jim Blondin from Plante Moran present annual audit.

Pam Hill – wants to thank us for helping go over this; page 1&2 goes over audit letter; unmodified; rely on these numbers; page 3-6 highlights from last year to this year; some changes; capping of employer contributions, good for the employees; management has been looking at Lake Callis within the near future of the Township facing unsustainable budget in the near future; need to address this from a long-term perspective.

Jim Blondin – goes over number on page 13 for revenues and expenditures; looks good; page 16 goes over the numbers for operating revenue and operating expenses and net position.

Pam Hill – page 11 goes over the unassigned 6.4 million; healthy; stable; did add to the fund balance; do have a lot of capital needs.

Jim Blondin – page 16; operating revenue is 7.1 million; operating expenses are 6.2 million.

Pam Hill – make sure you have the capital planning incorporated into the budget; how to fund it; look at grants; how do you fund these plans; page 1-3 follow up preaudit; note if there was any deviation, there was no deviation; page 4 cyber security; look at it with strengths and vulnerability; have that line item in your budget; definitely look into that; a lot of info on federal reporting; how to use ARPA funds; GASP 87; technology based; reporting by state; grant reporting; look at every year.

Slezak – I look back on the older audits and compare to see where we were and how have we progressed.

Miller – working with Plante Moran this past year made it a little easier.

Tallman – thanks to the departments; nice to see it go smooth; ARPA funding; consult about what we can do with ARPA.

Pam Hill – we have had presentations on the broader rules; we can not say what you can spend it on; obligation by 2024, spend by 2026.

Tallman – obligation is for the total?

Pam – yes, total.

Miller – going to have Kim explain what this is about.

Kim Sparks – software; balancing; recommended by Danielle; 3 or 4 to be trained on this.

Slezak – is this for incoming or outgoing?

Kim Sparks – just outgoing; it will flag something that is not right.

Slezak – what is the volume?

Kim Sparks – I did not do the research on that.

Slezak – what are they for?

Kim Sparks – schools; police; parks; miscellaneous is the problem when they code it that way.

Karr – what is the cost?

Slezak - \$15k.

Karr – in the 20 years I have been here we never had a problem.

Kim Sparks – it will help when you have someone that does payroll and accounts receivable.

Slezak – what is the process?

Kim Sparks – I have to go to each department if I have an issue.

Slezak – I am not understanding the problem?

Green – we post it in BS&A under codes.

Tallman – if she is saying that it takes that much longer at audit time, then possibly.

Miller – want to hire another person at a lower rate to help with this.

Kim Sparks – when I started working and training from Alma, I have not seen half the stuff that was in her basket.

Miller – Alma purposely held things from Kim, once I told Alma she would not be coming back to help part-time all training stopped from her.

Tallman – I have dealt with that in my business, you have to go back and try to find it and fix it.

Kim Sparks – it will be an easy transition for someone new to come in and learn.

Karr – who presented this to you?

Kim Sparks – Danielle from Plante Moran.

Karr – I want to see this first, before acting on this.

Slezak – Keagan said he would come in and demonstrate it.

Tallman – if that stops the auditors from coming in, possibly do it.

Green – we need to see it first.

Tallman – lets schedule a meeting on this.
