Slezak – they were confused; they just wanted to make sure they will get paid for the drawings.

Wright – what is our drawing budget?

Hawley – I would say no more than \$15K.

Slezak – I would think \$5K a piece.

Hawley – we are running into dead ends; maybe we need to not proceed with this.

Clark – we did catch them at the middle to end of their busy months; I don't know what a million dollars would get us or even 10 million.

Hawley – we don't know the scope of this.

Wright - that will probably be one question is how much you want to spend.

Clark - this is what a million will get us; and vice versa.

Wright – how many do we have? And pick out the areas we want to do.

Place – it will have to go out to bid and at least three companies have to bid.

Wright – forget the areas, how much do we want to spend?

Aboneaaj – we are looking to beautify; but have limited resources to allocate; two-three or four; maybe we table this idea all together and maybe shift focus on the electrical on Irish Rd; let us see how much it would cost to bury the electrical along Irish Rd.; with the hardscape you will not see the beautification for about three-four months of the year.

Slezak – that is a good idea to look into the electrical lines on Irish Rd.

Hawley – both directions are great; money to get these renderings are clueless; maybe scale back if it is a million; look into the powerlines; bond it out; master plan where it all comes together.

McMahan – how much do we want to spend; we want to have an idea; \$5K is not bad for drawings.

Clark – how much money do we have and are planning on spending?

Hoist – asking them to generate ideas for us at various cost so we can decide how much it cost.

McMahan – maybe reach out to Birch Run and find out how much it cost them to do

theirs.

Hawley – they could come in and ask the questions.

Place – by law you have to get three bids.

Hoist - \$5K is the least anyone would do a design for.

Hawley – maybe we just need one company to design.

Clark – this would be a rough draft?

Hoist – maybe have Wade Trim just do the designs.

Hawley – yes.

Wright – does not mean they will do the work; decide on a figure that we want to pay.

Clark – Lake Callis is this the last payment?

Hawley – yes.

McMahan – max I would like to spend is \$100K for 5 years.

Hawley - \$100K for 6 years; those areas we are looking at doing are huge; stone is expensive.

Wright – maybe do just a couple at a time until paid off.

Place – just to give an idea of cost of concrete, it cost us \$108K to do the sidewalks from the railroad tracks north to Davison Rd.

Clark – that is for a 5-foot sidewalk.

Hoist – if we have a price point, they would probably be more accurate.

Hawley – I personally would not mind going with Wade Trim; \$15K.

Hoist – I like the idea of three designs.

Hawley – let's all get on the same page.

**MOTION BY HOIST, SECOND BY MCMAHAN** to approve \$15K for Wade Trim to give us designs. Motion carried unanimously.

Clark – let us get an overhead cost of the electrical lines on Irish Rd.

Wright – do we have to have Consumers involved?

Slezak – yes, along with the cable, phone and any other provider that has lines.

Place – there may be some grants to apply for with the burying the lines; the sooner the better with all the new businesses coming in.

Slezak – it will take a few months.

Hawley – Jim, do you want to reach out to D&M?

Hoist – Planning Commission was trying to address the border behind the business on M-

15.; we need to find out from the lawyer if we can even do that.

Clark – maybe the beautification of fences would be a possibility.

Place – maybe do one business a year.

Wright – they are supposed to maintain those fences?

Place – yes, they maintain them and then people come along and knock part of the fences down over and over.

Hawley – anything else coming in Davison?

Place – yes, they are in the works; cannot discuss right now.

McMahan – what is happening with Hamlin Pub?

Place – they revised their site plans; strip mall is coming in now that Delta Tire backed out.
