Teresa Hammond-Cross – 9340 Lochmoor Dr, Davison, MI; concerned about Matt Smith becoming Clerk; he had during a past election threatened the Clerk from Houghton; how ironic he is wanting to run for Clerk of Davison; people don't like what he did; our hometown deserves better; need to have integrity.

Norman Fischer – 2216 Oakshade Dr, Davison, Mi; shame on the board if this has to go to elections.

Maggie Miller – 8257 Davison Rd, Davison, MI; special election will cost the township residents thousands of dollars; Matt Smith is qualified; they attempted to recall him but failed.

Jim Morrey – 1298 N Cummings Rd, Davison, MI; when is the round-about going to be done?; sledding hill are we getting rid of that stupid hill?

Lindsey Spiewak – 2218 Lily Ct, Davison, MI – I am going to talk and show some pictures of the AFC group home in our subdivision; I do want to thank Mr. Lattie for helping us; the State has too much say and little overseeing this; pictures say a thousand words; one person coming off heroin was laying in the middle of the road and would not move; another one spit in a cops face; tons of police and fire trucks and paramedics at all times of the day and night; this needs to be able to be controlled some; we are looking at moving out of that area.

Matthew Smith – 8228 Davison Rd, Davison, MI; thank you for saying that on the record that I threatened her because now I can sue you; thank you very much for saying that publicly; we still are not getting answers as to why Patrick Miller resigned; we keep switching the narrative; and two members of this board supported Pat Miller; and those two board members are going to be voting on the appointment of the new Clerk tonight;

Wendy Wolcott – 8228 Davison Rd, Davison, MI; this is ridiculous that the other applicants work 40-hours a week; how are you going to come in here and do a good job; how in the world can you do that; every person in here said they cannot be here 40 hours; but they can do it on there off time; this will cost all of us tons of money for a special election; for what because certain people on the board cannot put things behind them; and move forward; ultimately it is Jim and Tim that will work this person day in and day out and the other two will only see them once a month; honestly let's get this done today. APPROVE WALDORF & SONS FOR THE SLEDDING HILL GRADING

Place – back in 2015 when they created Lake Callis; this has been ongoing; efforts to get rid of the dirt; estimated about \$4million to get it taken away; been in the red-zone with Genesee County; turn it into a sledding hill; possibly income; over 300,000 yards of dirt; take a while; 5 bids went out and 5 bids came back; ranging from \$200,000 - \$768,000.
