#### DISCUSS PARKS SECURITY

Tallman – spoke with Casey on the security; we need to do something.

Reed – a lot of people; staff cannot control it.

Leffler – have you thought about reducing hours?

Reed – crowds that are coming in are not approachable; some type of security; having some sort of authority there helps.

Leffler – do we have a ban put in place?

Rendon – we can ban them; you just have to call us and we will be there if they have a problem; put something in place so we can ban them from the parks; tell them once if they don't want to comply call us and we can remove them from the park permanently.

Reed – I really don't like that I have to confront them.

Karr – we have security for holidays.

Reed – any weekend is just as bad.

Green - you have that every weekend?; has this happened this year?

Rendon – raise the prices on the weekends.

Reed – they complain about the prices, but still come in; and yes, every weekend; I am really talking about the incident that happened last year when I was followed back to my office; but nothing like that has happened like that this year.

Slezak - you have security cameras there?

Reed – yes, but we don't have the same as the Township.

Rendon – you can call 911 and we will be there.

Reed – if we have to call 911 that is the point, we don't feel comfortable; it would be nice to have someone there at all times; on weekends we have the same thing happening.

Harris – how often is there a manger there?

Reed – everyday.

Rendon – we were called for use of an atv in the park.

Green – how did they get thru the gate?

Rendon – from one of our police officers they were told they could give one ride.

Reed – that is not what I was told.

Green - why did you wait?

Rendon – the one staff told our police officer it was okay to do one ride.

Tallman – crowd responds differently to a man than a woman; like the do with a uniformed officer; holidays we approved.

Reed – all four days to be there.

Tallman – if you advise staff and if they don't do what they are told call 911; one warning and then trespass.

Green – sounds like staff training issues.

Rendon – trespass on permit basis.

Leffler – I agree with that; have pictures hanging so you know who can come in and who is not allowed.

Rendon – can you get license plates on your vehicles?

Reed – yes, but I am trying to get all the cars off Gale Road; trying to get them in.

Green – maybe get better cameras; have police be able to see them.

Rendon – we just have to drive over there.

Green – shut down the parks at 7pm.

Rendon – if you pay you usually don't mess up.

Green – trespass them; call 911 to get them there; we need to get an ordinance like Chief I.

said.

Slezak – you had four police at the festival of flags and it still happened.

Reed – it is a lot different when you have to enforce it; most of my staff is 16-20 years old.

Karr – they need to go up to them and tell them to stop; not approved.

Green – it sounds like a training issue.

Harris – does the staff have radios?

Reed – yes; most of the time they get a manager.

Tallman – my daughter had to deal with that about 5 years ago; not safe; maybe you board members need to spend at least 3 hours on a weekend up there and you will see what it is like; I didn't like my daughter working there when she did.

Green – maybe we need to shut the parks down; we don't really need the festival of flags; lock up; if Lori said it is that bad maybe we need to shut the park down.

Leffler – let's try that first and call 911 and then go from there; let the cops respond to the complaints.

Green – lets shut it down at 7pm.

Reed – between 4-5 is when it usually happens; start with telling them once, then we will call 911.

Place – do you have a Facebook page to say what can and can't happen?

Rendon – we maybe need to implement that.

Harris – it is going to cause staffing issues; will your staff tell them once, then we will get the call from 911; we are short staffed the next two weeks.

Rendon – let them know if you call the cops, we will trespass them.
