MOTION BY ABONEAAJ, SECOND BY HAWLEY to approve \$5,000 for the beautification grant. Also, make sure the landscape is taken care of that was previous discussed. Motion carried unanimously.

APPROVE PIERSON PET HOSPITAL BEAUTIFICATION GRANT
